I have co-authored other scientific publications, published in peer-reviewed journals on the topics of evidence-based medicine in gastroenterology and dermatology, and child and parental developmental and psychosocial health, with co-authors including colleagues from the Cochrane CSG. The Cochrane CSG paid a consultancy fee to me for my part in this work. I have also worked in an editorial capacity for the CSG and other Cochrane groups but was not involved in the editorial processes for this review. I am the editor responsible for updates for the Cochrane Upper Gastrointestinal And Pancreatic Diseases Review Group, I received a consultancy fee from McMaster University for this activity.

I have interests in evidence-based medicine generally and in the past 5 years I have received consultancy fees from the University of Nottingham and the University of Warwick, Dermatology Dept, UMCG, Groningen Netherlands, University of Bristol, Queen's University Belfast, and the Cochrane Schizophrenia Group, Plymouth University, Mc Master University, UCL, and Leicester University teaching hospitals, The Campbell Collaboration. I did not have any role in the administration or payment of fees from these funds. I was employed by Plymouth University (UK) until July 2014. I have previously held honorary academic appointments at QMUL, University of Bristol, Queens University Belfast and I am currently a visiting Professor at Coventry University. This is unpaid work and I attend meetings and use the research facilities at Coventry University on a regular basis (office space, library, email).

I am a member of the 'BOSS' trial data monitoring committee and I receive travel expenses relating to this voluntary activity. This is a gastroenterology clinical trial and unrelated to this review work.

My attendance at DDW in 2010 and the ISDE conferences in 2012 (gastroenterology) were generously supported by the ISDE. I accept refreshments and subsistence if provided by meeting organizers. I was paid expenses and a small honorarium for presenting at the BSG (Gastroenterology, not the topic of this review) in June 2014. I have attended NICE workshops as a contributor and received travel expenses for this activity.

I provide occasional unpaid research-related advice and consultancy for colleagues who approach me with requests for advice, and have also taken part in a Radio Leicester discussion about influenza (unpaid). From time to time I may recommend other

colleagues as candidates for consultancy work if I am not available or the work is outside my skill set.
